I work fifty hours every week, while Dustin calls me and harrasses me threatening me with law enforcement regarding our two sons. I don't know what his intentions are only that they aren't worth the breath that is in him. He makes no attempt to see the boys which I am grateful for that. Yet he tells me they are at the babysitters all the time, which he obviously does not understand that you have to work in order to pay bills and make sure the kids have everything that they need. Your honor I apologize for dragging this letter on but I think that Dustin needs to sit in jail again and should be made to work so that the children don't suffer because of his priorities not being together. I am so sick of having to worry about paying all of my daycare expenses or going to the grocery store trying to make ends meet. I do not recieve any government assistance and do not want to be forced into that. It is into that asituation that I don't want to be in. So with all respect please do something about this situation. I was in a very abusive relationship with Dustin and I had to leave him before he killed me. This is not a matter in which I just decided to leave because I would be happier trying to fight him in order for him to face up to his responsibilities and pay child support. Believe me your honor I wish more than anything that Dustin was a good person but I honestly feel in my heart that he is far from that, and never will be. Thank you for time and hope my letter to you in some way will benefit me in this case.
